Christin has been with the Refugee Service for three years, having held both supervisory and coordinator roles.

She has extensive experience designing and implementing mentorship programs that connect refugees and migrants with corporate and civil society volunteers to address employment barriers, leverage skills, and create pathways to sustainable career opportunities. In collaboration with corporate partners, she has developed bias-aware recruitment strategies and inclusive onboarding processes, particularly for entry-level positions, supporting companies in building more diverse and equitable workplaces.



Ragnar Granstrand

Inclusion Coordinator at the Culture and Leisure Department, Skellefteå Municipality, Sweden. Over the past ten years, the department has focused on developing practical methods to actively and meaningfully bring refugees into vibrant communities within the culture and leisure sector. These initiatives aim to nurture valuable skills, create connections, and build social networks that can play a key role in refugees' settling into other areas such as housing and employment. A central aspect of the work has been empowering refugee communities through leadership development and mentorship programs designed to support the growth of future leaders.



Anna-Maria Axelsson

Consultant in her own company, Cultural Geographer file. Bachelor, instructor for self-protection and volunteer resource groups. President of the Swedish Civil Defense Association since 2021. Before district chairman for 5 years. Active management of the organization during forest fires, flooding, clean-up and the pandemic.



Abdulrazzak Awf

I am from Damascus, Syria, and I have been working in the field of teaching music and singing all my life in Syria. In 2015 I left Syria due to the war that started in 2011 and moved to Turkey, where I lived and worked for two years as a translator between Arabic and Turkish. Then, at the end of 2017, I came to Lithuania through the UNHCR Resettlement Programme. Here I started to learn the language and work at the same time because I wanted to be independent. After a short period, I started working as a translator with refugees at Caritas and other organizations. Later, I moved to a social services center in Jonava - this experience was a turning point in my life. I was not only a translator, but I also helped refugees and other people to integrate into Lithuanian society. Thanks to this experience, I broadened my knowledge of working with refugees and took part in several trainings related to refugees. Today, I continue to work in my favorite field, working in a social services center and as the chairman of the Lithuanian Syriac community.



Sulaeman Alzouabi

Social mentor helping international protection beneficiaries integrate into the system in the Republic of Latvia. By education he comes from a medical background but, in 2018 he started work as an interpreter which led to involvement with international protection beneficiaries and the supporting organizations. Since 2019, he has been working as a social mentor with the organization "I Want to Help Refugees". Both as an interpreter and a social mentor he has accompanied international protection beneficiaries from the asylum seekers interview stage through the job interview stage and full integration into society. Sulaeman Alzouabi himself is an international protection beneficiary and he comes from Syria.



Yanika Wilen

Licensed social service professional specializing in Arab family issues. She works on the 'Father is Important' project at Mirsal ry and as a family work planner at Familia ry, focusing on counseling and peer support. Since 2024, she has chaired Kaapatut Lapset ry after seven years on its board. With personal experience in multicultural, blended, and large families, divorce, custody disputes, and parenting neurodivergent children, Yanika is also a licensed trainer for new experts by experience. She specializes in helping divorcing parents resolve custody agreements outside of court and is a trained Divorce Seminar facilitator. She recently rewrote 'Love and Parenthood in an Intercultural Family' - guide and continues advocating for better support for Arab and Finnish Arab families. A mother of six multilingual and multicultural children, she is dedicated to strengthening family support systems.



Mette Lherbier

Head of UCplus Language Center in Copenhagen, Denmark. UCplus Language Center is the largest provider of the Official Danish Language Education. We collaborate with 13 municipalities to provide free Danish classes to refugees and immigrants. Mette Lherbier has been head of UCplus Language Center in Copenhagen for 5 years and is also a board member of the association for Danish language schools. She has worked on language and labour projects for 20 years.



Louise Norstedt

Holds a Bachelor's degree in International Relations from the School of Oriental and African Studies (SOAS) and a Master's degree in Applied Linguistics from the University of Edinburgh. Her expertise lies in informal education, language acquisition, and integration. As Deputy Manager at ELVIRA Kunskapsutveckling, part of ABF Stockholm, Louise has designed and led multiple projects focused on Swedish language education for newly arrived immigrants. She specializes in developing practical, skills-based language programs that facilitate both social and professional integration.



Laura Perevičiūtė

Head of the Foreigners' Integration Group at the Ministry of Social Security and Labour of the Republic of Lithuania, with over 12 years of experience in social inclusion and EU fund investments. Since 2019, she has been coordinating the functions of the Responsible Authority for the Asylum, Migration, and Integration Fund in Lithuania. Since 2022, Laura has led the Foreigners' Integration Group.
